

## Kitware Support Services Terms and Conditions

By purchasing a Kitware Support Contract through Kitware’s online store, the CUSTOMER agrees to the following terms and conditions.

### 1. The Services

KITWARE will provide one year of support work (“Services”) not to exceed the Payment as defined in Section 3. Services may include, but are not limited to, software support, training, bug fixes, and the development of new features related to Kitware’s open-source software. All bug fixes and new features developed by KITWARE in performing these Services will be owned by KITWARE and may, at KITWARE’s discretion, be contributed to the appropriate open-source project.

### 2. Fee

The purchase price (“Payment”) paid by the CUSTOMER to KITWARE for the Services defined herein will constitute the ceiling for this effort. Services will be provided at an hourly rate based on labor category (Professional Services Fees) and these Professional Services Fees will be charged against the Payment until the Payment is fully spent or the one year term of this Agreement expires. ### 3. KITWARE Responsibilities

KITWARE represents that it will use Reasonable Efforts (the efforts that a reasonable person in the position of KITWARE would use) to perform the Services in accordance with this Agreement. KITWARE shall have sole discretion in staffing the tasks to be completed. KITWARE makes no guarantee regarding the amount of time it will take to provide the requested Services. KITWARE will not incur any expenses in excess of the Payment to perform these Services.

**4. Term**

This Agreement shall commence on the date of purchase ("Effective Date") and shall continue for one year (Term). Any unused portion of the Payment will be forfeit after the one year anniversary of the Effective Date.

**5. Indemnification**

The CUSTOMER shall defend, indemnify and hold harmless KITWARE from and against any claim, demand, suit, proceeding, damage, cost and expense, including, without limitation, attorneys' fees, which arise or result from the use or distribution of the CUSTOMER's products with any work performed by KITWARE under this contract embedded in such products.

**6. Disclaimer of Implied Warranties**

THE CUSTOMER EXPRESSLY ACKNOWLEDGES AND AGREES THAT THE CUSTOMER'S USE OF THE WORK PERFORMED UNDER THIS CONTRACT IS AT THE CUSTOMER'S SOLE RISK. THIS WORK AND RELATED DOCUMENTATION ARE PROVIDED "AS IS", "WITH ALL FAULTS," WITHOUT WARRANTY OF ANY KIND. THE WARRANTIES SET FORTH HEREIN ARE EXCLUSIVE WARRANTIES AND ARE IN LIEU OF ALL OTHER REPRESENTATIONS OR WARRANTIES, EXPRESS OR IMPLIED, STATUTORY OR OTHERWISE. KITWARE SPECIFICALLY DISCLAIMS THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT.

**7. Limitation of Liability**

THE CUSTOMER AGREES THAT KITWARE'S MAXIMUM LIABILITY TO THE CUSTOMER SHALL NOT EXCEED THE AMOUNT PAID BY THE CUSTOMER TO KITWARE AND IN NO EVENT SHALL KITWARE BE LIABLE TO THE CUSTOMER FOR ANY SPECIAL, INDIRECT OR CONSEQUENTIAL DAMAGES HEREUNDER, INCLUDING BUT NOT LIMITED TO, LOSS OF USE, LOSS OF PROFITS, OR LOSS OF DATA OR INFORMATION OF ANY KIND, HOWEVER CAUSED.

**8. Use of Name**

Kitware will not make use of Customer's name, trademarks or logo, or any variations thereof, without the prior written consent of Customer. Notwithstanding the foregoing, Customer agrees that Kitware may include Customer's name and logo in customer lists or related marketing and promotional material for the purpose of identifying users of Kitware's Services. Customer may revoke this limited right to use Customer's name and logo by providing written notice to Kitware.
